#### **Directors Report – Scott Dennis**

#### Intake/Eligibility Unit - Update

- New Program manager and Supervisor have officially started
- Currently recruiting for additional counselors
- Referrals have been coming in at steady pace with the online referral form
- Looking to increase workload once other positions are filled.
- Just initiated Electronic signature platform. Allowing the EDU to send out electronic documents that can be signed electronically.

## <u>Patrick – About the Electronic signature platform:</u>

- The Electronic Signature platform started as a pilot program through the EDU.
- The program is Cintrix it allows for the exchange of secure information with consumers
- Counselors would complete the form in office and send it through Cintrix to the consumer who will be prompted to type, or draw on tablet or phone their signature and then send back through Cintrix to the Counselor.
- Cintrix gives the ability for adding multiple signatures when needed
- Consumer will automatically receive a copy of the signed document through Cintirix.

#### Pre-Ets Intake:

- CTCI has ramped up, they have been working for about two months now and have assigned about eight hundred Pre-Ets. referrals to date and have processed about two hundred and fifty cases back to us.
- We have three hundred and fifty interviews scheduled with parents.
- Looking into how to send out electronically Pre Ets information that traditionally
  has been sent out through the mail so the consumer will receive it before they
  are contacted by the CTCI. Eventually we will implement that process with the
  VR Cases as well.

## **DORS Funding Forecast**

Projected to receive an increase in Federal funding between \$4.4 and \$4.5 million dollars in basic support for FY24 which starts July 1, 2023.

The state is required to match Federal funding and as of right now if we do not receive an increase in funds from previous years we will lose Federal funding over the next four years.

For every dollar the State falls short we lose \$4 dollars
