## Jody Boone, Acting Assistant State Superintendent

DORS received a Re-Allotment from the Rehabilitation Services Administration in the amount of \$4.95 million in addition to the \$51.6 million originally received for FY24.

# <u>Maryland Pathways to Partnership Initiative (MPPI) – RSA Disability Innovation</u> <u>Fund (DIF) Grant Update:</u>

This is a 5-year grant, awarded to DORS by the Rehabilitation Services Administration (RSA). The partners are four local education agencies (Allegany, Caroline, Charles, and Washington Counties), three centers for independent living (BACIL, Resources for Independence, and SMCIL), University of Maryland CTCI, Independence Now, MSDE DEI/SES, Abt Associates, The Parents' Place of Maryland, and the Maryland Department of Disabilities.

Our kickoff meeting will be at Turf Valley Resort on October 9,2024:

- We are expecting around sixty guests consisting of staff and partners.
- We will provide an overview of the grant.
- Introducing training models
- Going over the Outreach and Recruitment process
- Web site set up
- Implementation of services set for January 1,2025

### **Counselor Case Loads:**

- OFS Case load average is about 160 open, VR & Pre-ETS combined.
- Our caseloads are 2-3 times higher than the national average.
- On Sept. 23<sup>rd</sup> Beth lash along with OFS senior management will meet to look over the balance of OFS counselor caseloads and work on how to balance those caseloads statewide.
- Our 2year Mou pilot program with the University of Maryland CCTI unit ended last

month. We have taken back all Pre-ETS referral processes until a new MOU agreement is in place. Under the agreement, CCTI worked on and processed all Pre-ETS referrals and they reviewed all documents and interviewed students and family. This was a huge help for the counselors with managing caseloads and getting the student cases processed and started in a timely manner.

 Hoping to give CCTI access to the AWARE system. This will further streamline the process.

Samanth McGinley is our new Individual community Liaison (ICL). Samantha will give a brief presentation at the Retreat on her position, job duties, present and upcoming projects.

Assistant State Superintendent position Update: We are actively recruiting now for a new Assistant State Superintendent.

#### Toni March, Director of the Office for Blindness & Vision Services

- The SRC Sub committee met on Aug 28<sup>th</sup>.
  - We reviewed the number of students who attended various summer programs.
  - Went over Policy update.
  - Discussion on how the Adult learning experience program is being implemented in OBVS.
  - Concerns: Want to make sure the consumer is communicating with their employer and not just relying on their Job coach and IEP.
- MBEP has a new Vending Program Administrator, Vernon McNece and we are happy to have him aboard.
- OBVS had their training on the new ILOB review process. We have nine counselors across the state who service our Independent Living Older Blind.

## **Tom Liniak, Director WTC**

- We just finished our second cohort in Laurel for Retail Training in conjunction with CVS and just started our third.
- The 1st cohort ended with 72% employed and our 2nd ended with 100% employed.

- We run Food Service Internships at 2 of our Employer partner CommuniCare's facilities.
- Added a new component to our Work Readiness program, Functional Independence for Employment. This enhancement focuses on executive functioning, compensatory cognitive skills and education and training in physical endurance and proper body mechanics.
- We are Looking into adding a financial literacy component: Basics of Social Security to our Work Readiness program.
- In discussions with Prince Georges CC and Montgomery College about adding a Child Care employment training program in 2025.

## **Beth Lash, Director OFS**

- Deaf and Hard of Hearing Unit (DHHU) just celebrated their 1-year anniversary.
- I want to thank Sharon Plump for the excellent job she is doing in managing the DHHU. I believe it has made a huge difference in the delivery of services to the deaf.
- Excited to announce that OFS will be adding around six new staff members next month.
- We were able to expand our Eligibility Determination unit by four: a 3<sup>rd</sup> Supervisor, 2 additional counselors and an Administrative Aid.
- At our recent Terps succeed meeting we found out that our membership has been
  expanding, we are now at 15. Terps succeed is our comprehensive Transition
  program at the University of Maryland, Partnership program with the Developmental
  Disabilities Administration and University of MD. The program gives college
  experience to individuals with intellectual and Developmental disabilities. Provides
  relative course work to their job goal as well as internship experience on campus.
